Schedule of Test Dates and  
Description of Services  
(Aug 2010 - May 2011)

The ACT (American College Testing) is given at Oklahoma City University five times per year on national testing dates. The scores from this test can be reported to as many as five institutions, including OCU. To register for these tests, you may get a registration packet at any high school counselor's office. The cost of this test is \$29.00.

The residual ACT is an institutional test given at OCU in the months when the national ACT is not offered. The score from this test cannot be reported to any other institution; it is only valid at OCU. Students must submit payment for the residual ACT exam at least three days in advance to reserve a seat. Walk-ins will be accepted only on a space-available basis. To register for this test, please send your application to the attention of Denise Binkley at the address below. The cost of this test is \$50.00 and must be submitted with your application. Please make check payable to Oklahoma City University.

AP (Advanced Placement) tests are given by high schools to allow students the opportunity to earn college credit in selected subject areas. The OCU catalog outlines which tests are accepted and the scores required to receive credit. The Web link for the catalog is [www.okcu.edu/admissions](http://www.okcu.edu/admissions).

CLEP (College Level Examination Program) tests are administered at OCU once a month except for the Freshman Composition exam, which is given twice yearly. These tests allow students to receive college credit by taking subject examinations. The OCU catalog lists the subject area examinations and their corresponding courses. Please note that an individual taking the Freshman Composition CLEP exam must allow three hours for the exam because there is a writing component not present on other CLEP exams. The cost is \$90 per test and payment is to be made at the time of the exam. You may register with Denise Binkley, Director of Testing.
