GENERAL ADMISSION POLICY

Admission to attend Oklahoma City University (OCU) is considered to be a privilege rather than a right. The university does not discriminate against any individual because of age, sex, race, marital status, physical disability, or religious affiliation. Oklahoma City University is interested in students who want to learn. Admissions staff will carefully consider each application. Important factors that will be considered are academic records, recommendations from academic counselors or persons able to comment on your professional abilities, character and personality, and the interest and goals of the applicant in relation to the programs offered by OCU. The Office of International Admissions reserves the right to request any additional information before making a decision of admission. All transcripts test scores, correspondence or other materials submitted in conjunction with an application for admission become the permanent property of OCU and will not be returned. Providing false or incomplete information on this application may result in a denial of admission or a cancellation of registration.

A COMPLETE APPLICATION FOR ADMISSION CONSISTS OF THE FOLLOWING:

- A complete application form with passport photograph.
- A copy of passport ID pages.
- Certified copies of all academic records. The term “certified copies” refers to academic records issued by your previous school(s) with an official school seal or stamp on the document and should be sent directly to OCU by the previous school(s). It should not be a copy “issued to the student.”
- Original statement of financial support; official English translation is required. This statement should show support of at least U.S. \$37,269* for undergraduate studies and \$28,054* for graduate studies for a nine month period. If any dependents are accompanying the applicant to the United States, an additional amount of \$2000 per year must be shown for the support of the spouse and \$1000 for each child. Some degrees have extra fees.
* Tuition and fees subject to change.
- OCU requires a TOEFL score of at least 80 (iBT), 550 (international paper-based PBT), or an IELTS score of at least 6.0 overall and 5.5 on each band. OR completion of the intensive level 112 at the ELS Language Center. Students with a TOEFL score between 61 and 79 (iBT) or 500 and 549 (international paper-based PBT) may be provisionally admitted to some programs and begin their degree program full-time. Provisionally admitted undergraduate students must complete 24 credit hours with a 2.75 GPA, and provisionally admitted graduate students must complete 15 credit hours with 3.0 GPA to continue in the degree program. Students in ELS levels 110, 111 and 112 may enroll concurrently in OCU courses. Some degree plans have higher requirements.
- A GMAT/GRE score is required for the Master of Science in Accounting and MBA programs. Please go to additional notes at www.okcu.edu/admissions/iso/apply.aspx for more information.
- A non refundable application fee of U.S. \$70.00 made payable to Oklahoma City University. You may pay online or by check.

ADDITIONAL REQUIREMENT

- Two letters of recommendation (for graduate applicants only).
- If you are a transfer student from another university in the United States, you will need to have your current International Student Office complete an OCU transfer form and submit it to our office. The form can be downloaded at: www.okcu.edu/international/pdf/transfer_to_ocu.pdf. You will also need to complete the Dean’s recommendation form, which can be found at www.okcu.edu/admissions/iso/apply.aspx.
- Students applying to the Wanda Bass School of Music must also submit an audition tape/CD/DVD.
- Student applying to any Arts programs must also submit a portfolio of work.
- If you believe a personal statement would assist us in evaluating your application, you may include it with your other materials. If you choose to include a statement, it should tell us something about your background and your future aspirations, particularly in relation to your studies.

ACKNOWLEDGEMENT

Oklahoma City University recognizes its responsibilities as an educational institution to promote a productive student environment. This responsibility demands implementation of programs and services which facilitate that effort.
