Computer Services

Databases (available on campus)

- **EBSCO-** A collection of non-legal news, science, and business databases.
- **Hein Online-** A database of legal periodicals and the Federal Register from 1936-present.
- **Index to Legal Periodicals-** Indexes legal periodicals from 1980 – present.
- **J-Stor-** A searchable full text database of academic journals (not law reviews).
- **Legal Trac-** An index to legal periodicals with some periodicals in full text.
- **LexisNexis Congressional & Serial Set-** Current legislative materials and a historical collection going back 180 years in full text.
- **LLMC Digital-** A database of older Federal executive, judicial and legislative materials.
- **News Bank-** A database of over 500 national newspapers including the Daily Oklahoman from 1982 and the Tulsa World from 1989.
- **RIA Checkpoint** – A collection of tax research resources.

Public Access Shepard's Terminal

This powerful research tool instantly updates the current status and precedential history of primary and secondary legal materials. The terminal is located in the reference wing and is available to any patron of the library.
